SECTION 7. HANDLING AND STORAGE

7.1 PRECAUTIONS FOR SAFE HANDLING:
 Isolate from oxidizers, heat, sparks, electric equipment & open flame.
 Use only with adequate ventilation. Avoid breathing of vapor or spray mist.
 Avoid contact with skin & eyes. Wear OSHA Standard goggles or face shield. Consult Safety Equipment Supplier. Wear goggles, face shield, gloves, apron & footwear impervious to material. Wash clothing before reuse.

7.2 CONDITIONS FOR SAFE STORAGE, INCLUDING ANY INCOMPATIBILITIES:
Vapors may ignite explosively & spread long distances. Prevent vapor buildup. Put out pilot lights & turn off heaters, electric equipment & other ignition sources during use & until all vapors are gone. Keep in fireproof surroundings. Keep separated from strong oxidants, strong acids, strong bases. Keep cool. Do not store above 49 C/120 F. Keep container tightly closed & upright when not in use to prevent leakage.

7.3 NONBULK: CONTAINERS: Store containers in a cool, dry location, away from direct sunlight, sources of intense heat, or where freezing is possible.
